Directions for use:

Surface Preparation:

Substrate must be sanded using 120, 150 or 180 grit paper prior to coating. Aquaprime II Neutral should be sanded with 280/320 grit paper prior to being coated. Aquaprime II Neutral should be coated within (8) hours of being sanded for maximum adhesion. When recoating, the previous coat of Aquaprime II Neutral must be sanded and the next coat applied within (8) hours.

General Information:

Mix material before use. Add water to reduce if required and mix thoroughly. Apply by spray at 4 - 5 mils wet. Aquaprime II Neutral must be agitated thoroughly at all times to ensure product consistency. Contact with metal surfaces should be avoided. Keep from freezing.

Maximum film build of total coating system must not exceed 4 mils dry.

The completed coating system should be checked for required properties prior to start-up of production.
