Surface Preparation:

Wood substrate must be sanded using 120, 150 or 180 grit paper prior to staining. On wood such as maple, coarser sanding, such as 150 grit, should be performed to avoid polishing of the wood surface. Hand sanding in the direction of the grain following orbital sanding will remove swirl marks.

General Information:

Product must be thoroughly agitated before use and during application for color consistency.

Product can be tinted with 844 Tints up to 10%.

Dirty and clean rags must be disposed of in a safe and approved manner. The use of closed containers filled with water is the most appropriate way for disposal of the rags.

Drying time is very short and 20 minutes is sufficient prior to apply sealer. However, heavy coats in dark colors should get at least 30 minutes drying. The suggested drying time must be adhered to in order to ensure proper adhesion.
